WHEREAS, the National Insurance Crime Bureau encourages Mississippians to get at least three written estimates when hiring a contractor, check contractor credentials, and work closely with insurers during the entire rebuilding process; and

WHEREAS, the National Insurance Crime Bureau, in collaboration with its local and state partners in Mississippi, including law enforcement, first responders, legislators, and state officials, is committed to educating Mississippians about predatory practices by dishonest contractors; and

WHEREAS, the residents of Mississippi are encouraged to become familiar with contractor fraud and participate in the various programs during the fifth annual Contractor Fraud Awareness Week, May 18 – 22, 2026.
